WYFI FEES BULLETIN

Attention Wyoming Frontier Information Members (WYFI)

Pursuant to Wyo. Stat. § 9-2-131(b) and in consultation with its Executive Steering Committee and other stakeholders, the Wyoming Frontier Health Information Exchange has adopted Rules Chapter 1 which authorizes the Department's collection of reasonable participation fees for connection and access to the Health Information Exchange.

There are some providers that have already received information in reference to the process and an invoice displaying the amount of the fees that will be charged by the Department. The Department also has discretion over the waiving of fees when there is a federal emergency established.

Due to the current federal Public Health Emergency for COVID-19, the Department of Health, Division of Healthcare Financing requested a waiver of the fees for all users under the Rule. Currently, the WYFI is funded under the COVID-19 Health Disparties Grant thorugh May 30, 2023. Initially, the Department had planned on assessing participation fees for connection and access to the Health Information Exchange (HIE) as of January 1, 2023, however, since the funding is granted through May 30, 2023, we have decided to extend the waiver of fees through June 30, 2023.

We will be working over the next several months on reviewing our Participation Fees and will be providing notice to you at a future date of what your annual billing amount would be for the year starting July 1, 2023.

GET CONNECTED!



In long-term and post-acute care (LTPAC) settings, care providers are faced with enormous challenges when coordinating care for patients transitioning to and from multiple and diverse care settings. Hours can be spent making phone calls and tracking down information on patient status, lab results, medications, and treatment plans. Wyoming now has a secure health information exchange (HIE), called the Wyoming Frontier Information (WYFI) that gives care providers in your organization access to patient records from hospitals and clinics across the state.

The WYFI allows streamlined access to patients' medical history, saving valuable time searching through faxes or making phone calls. It decreases costs as a result of reduced faxing, printing, mailing files, and other administrative tasks. It also reduces costs and physical risks to patients by avoiding unnecessary duplicate tests and procedures.

The WYFI would like all Wyoming facilities to make a connection to share information in the statewide HIE as well as accessing information to ensure quality patient care.
